Clinerion GROWS! New use case: precision medicine.

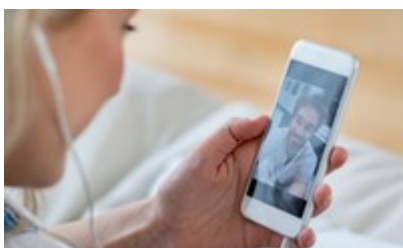
